

LIMITED WARRANTY

Thank you for your purchase of a Fusion Furniture Inc. product. We express our confidence in the merchandise by advising you of our Limited Warranty. Please read the terms of coverage carefully. Retain your proof of purchase and this printed warranty to substantiate your claim in the event warranted service requirements should arise. This warranty applies under conditions of normal household usage and does not apply to defects resulting from misuse, accidents, negligence or commercial usage.

FRAMES

Under normal use and conditions, Fusion Furniture Inc. warrants the frame to be free from manufacturing defects and defective materials for one year when upholstered in its original fabric.

SPRINGS

All sleeper mechanisms and spring systems are warranted by Fusion Furniture Inc. for one year against workmanship and material defects under normal use and conditions.

CUSHIONS

All foam seat cushion cores are warranted by Fusion Furniture Inc. for one year from the date of original purchase. All cushions will soften and conform to the shape of the user over time. This is not considered a manufacturing defect. This warranty covers the actual loss of foam resiliency as a result of defective materials.

MATTRESS

All sleeper mattresses are warranted for one year by Fusion Furniture Inc. against defects in workmanship and materials. ** Please note that a mattress folded inside the mechanism may become creased at the fold lines. This is not a defect in the product. **

FABRIC

All fabrics are warranted for one year from date of original purchase. This warranty does not cover fading, piling or shrinkage and is not valid where there is evidence of

heavy soiling and abuse. Fabric damage from failure due to chemical treatment or improper cleaning is also excluded from this warranty.

WOODEN ACCENT CHAIRS AND OTTOMANS

****IMPORTANT**** Fusion Furniture Inc. will not warranty any damage to any of our wooden accent chairs and ottomans caused by over tightening of screws and bolts. Please pay close attention when tightening and only tighten with wrenches provided. ****

WARRANTY INFORMATION

Fusion Furniture Inc. will either repair or replace at its option any Fusion Furniture Inc. product which has a defect in materials or workmanship covered by the Limited Warranty without charge. This warranty does not cover items that were purchased as distressed or second hand. To obtain service, you must return the product to the furniture dealer from whom you purchased the product along with this Limited Warranty and proof of date of original purchase. All packing and transportation charges for delivering the product requiring service to the furniture dealer are the responsibility of the original purchaser. Fusion Furniture Inc. will pay for all transportation charges between the dealer and our factory. ** In no event shall Fusion Furniture Inc.'s responsibility exceed the purchase price of the product or replacement. **

IMPORTANT INFORMATION

This warranty extends only to the original consumer purchaser. Fusion Furniture Inc.'s liability under this Limited Warranty is limited to repair or replacement of the defective product at its option.
