These warranties do not apply to furniture intentionally misused, or to damage resulting from negligence, exposure, rental or commercial use, pet damage, improper cleaning, or other unreasonable use, or to fabric/leather damage or failure due to additional chemical treatment, improper cleaning, or when heavy soiling or abuse is evident. Fabric/leather fading, pilling, shrinkage, stretching, fabric/leather wearability and colorfastness are not covered by this warranty.

These warranties are not transferable. In Flexsteel's Limited Warranty, "Lifetime" is defined by the life of the original cover.

In the event of defects, report them promptly to your Flexsteel retailer with proof of purchase. If the product is still under warranty, your Flexsteel retailer will make arrangements for repair or replacement. If the product is more than one year old, the warranted product will receive parts at no charge, but the owner is responsible for costs involving shipping and labor for repair.

Leather is a natural material and minor variations between floor samples and custom-order pieces may occur and are not covered under this warranty.
